I. The duration and summary scope of the contract: The construction period is 8 months. The project consists in the reconstruction of Ulza's road. The Works consist on upgrading works. The road will be reconstructed in order to increase the assets, easing the movement of habitants and the visitors' access.

Required works are mainly earthworks, concrete works, asphalt works, concrete reinforcement works and greenery works.

The Site is located at Mat municipality.

II. The selection method used: The Most Advantageous Bid.

III. The Bidder submitting the successful Bid: JV "Uleza Ndertim" shpk & "Alba Konstruktion" shpk. Adr. Rr. "Zef Jubani", N. 15, H 19/1, Kodi 1019, Tiranë, Rr. "Frederik Shiroka", pallati i ri, Shk. C, Tiranë.

IV. The Contract price of the successful Bid: 215,624,812 ALL (net of VAT) – 258,749,774 ALL (VAT included).

V. The Bidders who submitted a Bid:

- 1) JV "Riviera" shpk & "Consorzio Stabile EBG"
- 2) "Gjoka Konstruktion" sha
- 3) JV "Uleza Ndertim" shpk & "Alba Konstruktion" shpk
- 4) "GPG Company" shpk

VI. The bid prices as read out at opening of financial parts of bids:

- 1) JV "Uleza Ndertim" shpk & "Alba Konstruksion" shpk – 215,624,812 ALL (net of VAT) – 258,749,774 ALL (VAT included).
- 2) "GPG Company" shpk – 223,502,604 ALL (net of VAT) – 268,203,125 ALL (VAT included)

VII. The bid prices as evaluated:

- 1) JV "Uleza Ndertim" shpk & "Alba Konstruksion" shpk – 215,624,812 ALL (net of VAT) – 258,749,774 ALL (VAT included).
- 2) "GPG Company" shpk – 219,758,604 ALL (net of VAT) – 263,710,325 ALL (VAT included)

VIII. The unsuccessful bidders and the reasons the bids were unsuccessful:

1) JV "Riviera" shpk & "Consorzio Stabile EBG"

The bid does not meet the qualifying criteria, conforming to all the terms, conditions and specifications of the Bidding Documents as follows:

3.1 (ii) Financial Capabilities. The criterion is not fulfilled.

The JV member "Consorzio Stabile EBG" has not submitted (not even declared) the turnover of year 2016.

3.1 (iii) Financial Capabilities. The criterion is not fulfilled.

The JV member "Consorzio Stabile EBG" has submitted only the balance sheets for years 2011 to 2015. It has not submitted the balance sheets for year 2016.

The above mention documents are not submitted in the acceptable form as per bidding documents BDS 32.2.. They are not presented in compliance with legislation for notarization, legalization, apostille, etc.). Therefor they cannot constitute basis for the bid evaluation.

3.2 Financial Capabilities. The criterion is not fulfilled.

The JV member "Consorzio Stabile EBG" has not submitted (not even declared) the turnover of year 2016 and it has not submitted the balance sheets for year 2016.

4.2.b) Specific Construction Experience. The criterion is not fulfilled.

The bidder has declared:

Excavations works: 287,191 m³

Concrete works: 9,784 m³

Asphalt and binder works: 86,221 tons

Crushed stone works: 63,011 m³

The Bidder neither fulfills the sub-requirement for Concrete works because it has declared 9,784 m³ as opposed to 14,000 m³ requested, nor has submitted the supporting documents for all the declared volumes. "Consorzio Stabile" has not submitted IPC for two of the contracts. The supporting documents for the declared contract "Tamare Vermosh lot 1" are not submitted.

Furthermore all documents are not submitted in the acceptable form as per bidding documents BDS 32.2.. Therefor they cannot constitute basis for the bid evaluation.

2) "Gjoka Konstruksion" sha

7. Multiple Tenders. The criterion is not fulfilled.

The bidder does not meet the aggregate of the capacity requirements for each of the works contract "Reconstruction of Kanine's road, Vlore" and "Reconstruction of Ulza's road, Mat"

The bidder submitted the following personal key staff for the execution of the contract: Mihallaq Spirollari, Rajmonda Hoxha, Rakip Spahiu, Erlin Kociaj, Koco Birbo, Gjergj Kerkuti, Ardial Halimi. All the above mentioned staff is already involved with "Gjoka Konstruksion" sha in the works "Reconstruction of Kanine's road, Vlore".

Furthermore the following trucks with plate numbers: TR 3546 U, TR 8964 N, TR 8965 N, AA102 RL, AA 699 RH, AA 667 RH, AA 403 BH presented as key equipment are the same with the ones involved in the contract "Reconstruction of Kanine's road, Vlore", contract which has been awarded to "Gjoka Konstruksion" sha.
