Assignment Description: The Government of Albania has received a loan from the Council of Europe Development Bank (CEB) in an of EURO 28,700,000 toward the cost of the "Community Works IV: Development of the Albanian Alps and Coastal Areas" Project, and it intends to apply a portion of the proceeds of this loan to eligible payments for goods, works, related services and consulting services to be procured under this project.

One of the project objectives is the urban requalification of the territory in Albanian Alps area and Vlora region. The Consultant will supervise civil works that will be carried out in the frame of this project, including monitoring, inspection and reporting activities.

Assignment Start Date and Duration: The overall envisaged period of implementation of the project is 10 months.

Maximum Budget available for the Assignment: The maximum budget for the assignment is 7,324,000 Albanian Leke (VAT excluded) and shall be specified in the Request for Proposal.

## **Consultant Profile:**

1. The Consultant should have previous experience in the supervision of civil works in

- road infrastructure projects.
- 2. The Consultant shall have completed projects with value of services not less than 7,300,000 ALL (VAT excluded) in the required fields of expertise described above, within the 3 (three) calendar year period prior to the year of closing date for submission of applications.
- 3. The average annual turnover of the candidate in the last 3 (three) years must exceed 17,500,000 ALL, or equivalent; and
- 4. The averages of cash and cash equivalents at the beginning and end of year are positive.

Consultants satisfying the above criteria shall be ranked against the same criteria and a maximum of the top six shall be shortlisted.

**Status:** The ADF now invites eligible consultants to indicate their interest in providing a team to perform these Services. Interested consultants must provide information indicating that they are qualified to perform the Services (company registration documents, brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may associate to enhance their qualifications.
