The objective of the services by the Consultant is to, but not being limited to:

- Prepare the Environmental documents for the new upcoming projects;
- Monitor the Environmental component during construction of works for all the projects.

Timing

The contract will be for an initial period of 5 months (subject to extension), based on the satisfactory performance of the incumbent's duties and responsibilities.

The Environmental Expert shall be engaged on part time basis with a maximum input of 15 working days per month, to be activated as per the request of Client. The remuneration will be paid to the Consultant based on the working days for each assignment and submission as requested by the Client.

Qualifications and Experience

The Consultant is required to have the following qualifications/experience:

- Bachelor's degree in environmental engineering or similar fields;
- Sc. in environmental related fields will be considered as an asset;
- Certified from the Ministry of Tourism and Environment with as Environmental Impact Assessment specialist and Environmental Audit.
- Registered with an active License from the National Business Center for the operations of environmental impact assessments and relevant activities.

- At least 5 years of experience in consultancy services and preparation of Environmental documents as ESIAs, ESMPs with international standards (WB, EBRD, KFW, etc).

- Past experience in undertaking supervision services as environmental expert.
