1. The Government of Albania has received financing from the World Bank toward the cost of the Regional and Local Roads Connectivity Project (RLRCP), and intends to apply part of the proceeds toward payments under the following contract.

Albanian Development Fund (ADF) is the Project Implementing Agency for the "Regional and Local Roads Connectivity Project (RLRCP)" Project.

2. ADF now invites sealed Bids from eligible Bidders for:

RLRCP/1/1.3/2018, "Reconstruction of the road "Fier – Seman", Lot 1". The construction period is 18 months. The Project consists of the reconstruction of the first lot of Fier – Seman road 7.6 km, in the Municipality of Fier.

The proposed reconstruction will not change the road alignment. However, the cross section will be widened and road works will consist of sand-gravel sub base, crushed stone base, bituminous conglomerate, and binder/wearing courses (hot mixed asphalts).

In addition to drainage works and ensuring the functionality of irrigation system alongside the road, the project includes the construction of two new bridges and the rehabilitation (wide and retrofitting) of two others.

The Site is located at Fier municipality.

Bidding will be conducted through international competitive procurement using Request for Bids (RFB), Small Works (Two-Envelope Bidding Process) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July 2016 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
