Procurement of Works for: "Construction of individual houses in areas affected by the earthquake"

Name of Project: Reconstruction Programme for the Affected Areas after Earthquake Disaster in Albania

Government of Albania intends to support the recovery of areas affected by the earthquake natural disaster happened in Albania in November 2019, through a government funding program that will serve to rebuild and rehabilitate the situation in the country.

The Albanian Development Fund and the Municipality of Tirana now invites bids from eligible bidders for the "Construction of individual houses in areas affected by the earthquake"
The object of the framework agreement includes construction of individual houses according to model projects (1+1, 1+2, 1+3) in the territory of the municipalities: -Durrës, Kamza, Kavaja, Rrogozhina, Krujë, Kurbin, Lezhë, Mirditë, Shijak, Vora and Tirana.

The construction of individual houses will have distribution in the territory of the abovementioned municipalities. Their construction can be done in groups or separately (in existing houses) according to the designation of the construction sites specified in the Compulsory Local Plans.

Bidding will be conducted through the procedures as specified in the national legislation of the public procurement.

Type of procurement procedure: "Limited Tender" (Framework agreement)

Limit fund/ approximate value of the contract /framework agreement: approx. 42,500,000.00 Euro excluding VAT or approx. 51,000,000.00 Euro including VAT for the Albanian Development Fund and approx. 14,800,000.00 Euro excluding VAT or approx. 17,760,000.00 Euro including VAT for The Municipality of Tirana.

## Interested bidders should fulfil the following Specific qualification criteria:

#### Economic/Financial Capacity of Economic Operators:

- a) The average turnover realized by the Economic Operator during the last three years shall not be less than 6,900,000.00 Euro excluding VAT or 8,280,000.00 Euro including VAT. In order to verify the fulfillment of this condition the Economic Operator shall submit a statement from the responsible taxation authority regarding the annual turnover of the last 3 (three) years.
- b) The Economic Operator must submit copies of the balance sheets of the last three years, submitted to the relevant taxation authorities, confirmed by this authority, which should show that no loss has been incurred in at least two consecutive years.

### Technical capacity:

Successful experience in executing at least:

a. Similar works for a single object at a value not less than 4,470,000 Euro excluding VAT or 5,364,000 including VAT carried out by the economic operator during the last three years from the date of the procurement procedure.

or

b. Similar works up to a limit with a total monetary value of the works executed during the last three years from the data of the procurement procedure is at a value of not less than 17,860,000 Euro excluding VAT or 21,432,000 Euro including VAT.

The fulfillment of one of the above mentioned conditions makes the offer eligible.
